Each year, IAALS recognizes individuals and groups who exemplify the spirit of innovation and leadership that we champion as we work toward building a legal system that is accessible, fair, reliable, and accountable. In our 20th anniversary year, we are proud to honor five individuals—each reflecting one of IAALS' core values and the leadership needed to rebuild justice. Together, these honorees represent the values that will guide the future of our legal system and our shared pursuit of a more accessible and innovative path forward.

2026 REBUILDING JUSTICE AWARDEES



Dave Byers, Director of the Administrative Office of the Courts at the Arizona Supreme Court, will be honored for *Questioning the Status Quo* through visionary leadership that has transformed Arizona's courts into a national model for reform.



William C. Hubbard, Dean of the University of South Carolina Joseph F. Rice School of Law and past President of the American Bar Association, will be recognized for *Letting Data Guide the Way* and advancing evidence-based reform through decades of leadership in law, education, and policy.



Stacy Rupprecht Jane, Director of Innovation for Justice (i4J), will be honored for *Centering the People* by expanding access to civil legal services and elevating the voices of those too often unheard.



Chief Justice Nathan L. Hecht (Ret.), Supreme Court of Texas, will receive recognition for *Finding Common Ground* in uniting diverse voices across Texas and beyond to advance justice through collaboration.



Sateesh Nori, Chief Futurist at Law Droid, will be celebrated for *Setting Our Sights on Tomorrow* through his visionary, tech-forward approach to expanding access to legal services.

FIRESIDE CHAT

The highlight of the evening program will be a fireside conversation bringing together IAALS' founding and current leadership alongside current and former state chief justices. Together, the panelists will reflect on two decades of reform and impact, examine today's challenges and opportunities, and share forward-looking perspectives on rebuilding the justice system and advancing IAALS' vision of a world where everyone has a clear path to justice.



Brittany Kauffman is the Chief Executive Officer of IAALS, where she leads national efforts to advance data-driven solutions that strengthen courts, promote judicial independence, and improve access to justice. She works closely with judicial leaders and policymakers to translate research into practical, impactful reform.



Rebecca Love Kourlis is the Founding Executive Director of IAALS and a former Justice of the Colorado Supreme Court. She is a nationally recognized leader in civil justice reform, with a distinguished career focused on strengthening the fairness, efficiency, and accessibility of the courts.



Chief Justice Monica Márquez serves on the Colorado Supreme Court, where she was appointed in 2010 and began her term as Chief Justice in 2024. Her career includes extensive experience in appellate practice and public service, including prior service in the Colorado Attorney General's Office.



Bridget Mary McCormack is President and CEO of the American Arbitration Association—International Centre for Dispute Resolution. A former Chief Justice of the Michigan Supreme Court, she is a leading voice in dispute resolution, legal innovation, and the modernization of justice systems.

We will also present the **2026 Alli Gerkman Legal Visionary Award** to Elisa "Emo" Overall. This award recognizes innovators, risk takers, visionaries, and emerging leaders who bring new perspectives and a reform-minded approach to improving the legal system.



Elisa Overall is the Executive Director of the Colorado Access to Justice Commission. She leads statewide efforts to improve access to civil justice and has extensive experience working with courts, legal service providers, and stakeholders to address systemic barriers within the justice system.
