Up and down the income scale, the legal needs of Americans are going unmet. Systems created hundreds of years ago demand evolution. The status quo is rigid, inaccessible, slow, and costly—and doesn't account for the complex realities that people face on a daily basis.

**66%** Americans who experienced at least one legal problem over the last four years.

**70%** Civil and family cases that include at least one side without a lawyer.

**120M** Legal problems that do not reach a fair resolution each year.


