NOTE: When all judges in a particular state are appointed by the governor (with or without assistance from a judicial nominating commission) or elected by the legislature, then what these charts label the *informal method of selecting state judges* is the same as the *formal method of selecting state judges*. On the other hand, when judges are elected by the voters, the *informal method of selecting state judges* is the method that is used to fill judicial vacancies that occur between scheduled elections.
